

**The Essex County Council (Colchester Borough) (Waiting Restriction)
(Consolidation) (Amendment No.47) Order 2013**

WHEREAS the Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order may be cited as The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No.47) Order 2013 and shall come into operation on 8 November 2013.
2. The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 (hereinafter referred to as '2008 Order') is hereby varied by including the following:

LIST OF SCHEDULES to include:

43D. Limited Waiting 1 hour, No return within Two Hours 8am-6pm Mon-Sun

Part II – Article 6 of the '2008 Order' to include:

xlvi (a) wait between 8am and 6pm on Mondays to Sundays inclusive in the lengths of roads specified in Schedule 43D for a longer period than 1 hour or, if a period of less than 2 hours has lapsed since the previous period of waiting by the same vehicle in the same length of road;

3. The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 (hereinafter referred to as '2008 Order') is hereby varied is hereby varied to the extent detailed in the Schedule to this Order
4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the Act or by any other enactment.
