(b) (i) the badge is exhibited on the dashboard or fascia of the vehicle so that Part 1 of the badge is legible from the kerbside, or

(2) For the purpose of this Order a vehicle shall be regarded as displaying a disabled person's badge in the relevant position, if -

"parking disc" has the same meaning as in Regulation 8 of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Wales) Regulations 2000;

"disabled persons badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000;

1. This Order shall come into operation on 22nd December Two thousand and fourteen and may be cited as "The County Borough of Conwy (Disabled Person's Parking Places) (No. 1) Order 2014".

The County Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2 and 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

THE COUNTY BOROUGH OF CONWY (DISABLED PERSON'S PARKING PLACES) (NO. 1) ORDER 2014

4. Save as provided in Article 5 of this Order no person shall, except upon the direction or with the permission of a Police Constable or Civil Enforcement Officer in uniform, cause or permit any vehicle to wait in the lengths of road referred to herein for so long as may be necessary to enable:-
- (a) The vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in connection with any of the following operations, namely:-
- (i) Building, industrial or demolition operations.
- (ii) The removal of any obstruction to traffic.
- (iii) The maintenance, improvement or reconstruction of the said lengths of road.
- (iv) The laying, erection, alteration or repair, in or in land adjacent to the said lengths of road, of any sewer or of any main pipe or apparatus supplying of gas, water, or electricity, or of any telecommunications apparatus as defined in the Telecommunications Act, 1984.
- (b) The vehicle, if it cannot conveniently be used for such purposes in any other road to be used in the service of a local authority or a public utility company in pursuance of statutory powers or duties.
- (c) The vehicle of a universal service provider under Section 125 of the Postal Services Act 2000
6. The County Borough Council (Prohibition and Restriction of Waiting and On-street Parking Places) Consolidation Order 2006 is hereby revoked insofar only as it relates to the restrictions specified in Schedule 5 of this Order and shall otherwise remain in full force and effect.
7. The County Borough Council (Disabled Persons Parking Places) (No 1) Order 2007 is hereby revoked insofar only as it relates to the restrictions specified in Schedule 5 of this Order and shall otherwise remain in full force and effect.
8. The County Borough Council (Disabled Persons Parking Places) (No 1) Order 2008 is hereby revoked insofar only as it relates to the restrictions specified in Schedule 6 of this Order and shall otherwise remain in full force and effect.
9. The County Borough Council (Disabled Persons Parking Places) (No 1) Order 2010 is hereby revoked insofar only as it relates to the restrictions specified in Schedule 7 of this Order and shall otherwise remain in full force and effect.
10. The County Borough Council (Disabled Persons Parking Places) (No 1) Order 2012 is hereby revoked insofar only as it relates to the restrictions specified in Schedule 8 of this Order and shall otherwise remain in full force and effect.
