

THE COUNTY BOROUGH OF CONWY (CONWY QUAY)
(PROHIBITION AND RESTRICTION OF WAITING) ORDER 2007(AMENDMENT) ORDER 2010

The Conwy County Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 1(1), 2(1) to (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. This Order shall come into operation on the ~~28~~^{2nd day of June Two thousand and ten and may be cited as "The County Borough of Conwy (Conwy Quay) (Prohibition and Restriction of Waiting) Order 2007 (Amendment) Order 2010".}

2. (1) In this Order:-

The Conwy County Borough Council (Conwy Quay) (Prohibition and Restriction of Waiting) Order 2007 is hereby amended insofar as the words and figures –

Schedule 1
(No waiting at any time)

Conwy Quay	Both sides; from its junction with Town Ditch Road to its junction with Conwy Road, except on its north-easterly side from a point 96 metres north-west of Conwy Road for a distance of 28 metres in a north-westerly direction

Schedule 2
(Permitted Boat Owners only, waiting limited to 60 minutes, no return within 120 minutes)

Conwy Quay	North-easterly side; from a point 96 metres north-west of Conwy Road for a distance of 21 metres in a north-westerly direction

Schedule 3
(Disabled parking only)

Conwy Quay	North-easterly side; from a point 117 metres north-west of Conwy Road for a distance of 7 metres in a north-westerly direction

Schedule 1
(No waiting at any time)

Conwy Quay	Both sides; from its junction with Town Ditch Road to its junction with Conwy Road, except on its north-easterly side from a point 113 metres south-east of Lower High Street for a distance of 31 metres in a south-easterly direction

(Permitted Boat Owners only, waiting limited to 60 minutes, no return within 120 minutes)

Conwy Quay	North-easterly side; from a point 126 metres south-east of Lower High Street for a distance of 18 metres in a south-easterly direction

(Disabled parking only)

Conwy Quay	North-easterly side; from a point 113 metres south-east of Lower High Street for a distance of 13 metres in a south-easterly direction

3. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
