

**THE COUNTY BOROUGH OF CONWY (FFORDD Y MORFA, ABERGELE)**  
**(PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT) ORDER 2007**

The Conwy County Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 1(1), 2(1) to (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. This Order shall come into operation on the <sup>20<sup>th</sup></sup> day of <sup>December</sup> Two thousand and seven and may be cited as "The County Borough of Conwy (Ffordd y Morfa Abergele) (Prohibition and Restriction of Waiting) (Amendment) Order 2007".

2. (1) In this Order:-

The Conwy County Borough Council (Prohibition and Restriction of Waiting and On Street Parking Places) Consolidation Order 2006 is hereby amended insofar as the following restrictions in respect of the roads listed below shall be added to the roads or sides of roads referred to in paragraph 7 of Part II thereof and identified on the Plans attached thereto.

- a) no waiting 8.15am to 9.15am and 3pm to 4pm, Monday to Friday on the length of road in Schedule 1 hereto is amended to no waiting 8.30am to 9.30am and 2pm to 4pm, Monday to Friday.
- b) School buses only in term time between 8.15am to 9.15am and 3pm to 4pm Monday to Friday on the length of road in Schedule 2 hereto is amended to loading/unloading by school buses only 8.30am to 9.30am and 2pm to 4pm Monday to Friday.

**Schedule 1**

<b>Ffordd y Morfa</b>	<b>Southern side;</b> from its junction with Maes Canol to a point 15 metres west of its junction with Faenol Avenue

**Schedule 2**

<b>Ffordd y Morfa</b>	<b>Northern side;</b> from a point 47 metres west of its junction with Faenol Avenue for a distance of 36 metres in a westerly direction

3. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
