

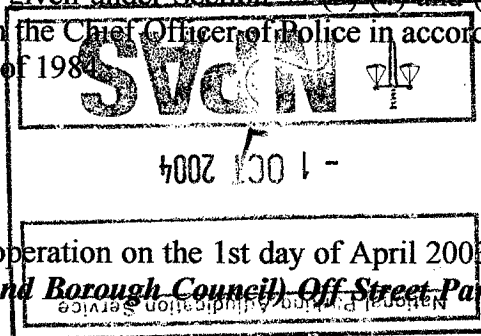
THE COPELAND BOROUGH COUNCIL OFF STREET CAR PARKING
ORDER 2003

The Council of the Borough of Copeland (hereinafter referred to as "the Council" in exercise of its powers under Sections 32, 35, 45, 46, 47, 48, 63a and Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act as so amended is hereinafter referred to as "the Act of 1984 ") and of all other enabling powers and with the consent of the County Council of Cumbria given under Section 39 (3) (4) and (5) of the Act of 1984 and after consultations with the Chief Officer of Police in accordance with paragraph 20 of Schedule 9 of the Act of 1984

PART 1

1 Commencement and Citation

- (i) This Order shall come into operation on the 1st day of April 2003 and may be cited as the ***(Copeland Borough Council) Off Street Parking Places Order 2003.***



2 Interpretation

- (i) In this Order except where the context otherwise requires the following expressions have the meanings hereby assigned to them.
- A "The 1984 Act" and "The Act" means the Road Traffic Regulation Act, 1984.*
- B "The 1991 Act" means the Road Traffic Act 1991*
- B "goods vehicle" - means a vehicle which is constructed or adapted for use for the carriage of goods or burdens of any description*
- C "passenger vehicle" - means a vehicle which is constructed or adapted for use solely for the carriage of passengers and their effects*
- D "invalid carriages" - has the same meaning as in Section 136 of the Act of 1984*
- E "disabled persons vehicle" - has the same meaning as in the Local Authorities' Traffic Order (Exemptions for Disabled Persons) (England and Wales)(Amendment) Regulations 1975*
- F "owner" - has the same meaning as in Sections 111 (3) and (4), 142(1) and paragraphs 11(2) and (3) of Schedule 172 of the Act of 1984*
- G "parking attendant " - means a person authorised by or on behalf of the Council to supervise any parking places*
- H "parking places" - means any area of land or building specified by name in column 1 of the Schedule of this Order*
- I "parking ticket" - means a ticket or pass issued by the Council authorising the parking of a designated vehicle on the parking place on which the ticket was issued*
- J "prescribed hours " - in respect of the parking places comprised in the Schedule hereto means the period between 8.00 am and 8.00 pm on charged spaces and 24 hours on Off Street Residents Parking Places on any of the days specified in the Schedule,*
- K "ticket machine " - means an apparatus of a type and design approved either generally or specifically by the Secretary of State for the*

Environment for the purpose of this Order being apparatus designed to indicate the time by a clock and to issue parking tickets indicating the payment of a charge and the date and time at which the charge was made

L "driver" - in relation to the vehicle waiting in the parking place means the person driving the vehicle at the time it was left in the parking place.

(a) in the event of the of Council being unable, for any reason whatsoever, to identify, and/or reasonably contact that person:

(i) the owner, being the person registered as the keeper of the vehicle with DVLA or otherwise identified as the keeper at the time of the offence OR:

(ii) in relation to hired or leased vehicles, the person identified by the hire company as the hirer/lessee at the time of the offence.

M "Parking disc" means a disc issued by a Local Authority which complies with the requirements of the British Standard Specification for Parking Discs (BS No. 4631 1970) is capable of showing the quarter hour period during which a period of waiting began.

N "Parking Permit" means a permit to use a parking place listed in column 4 of the attached schedule issued by the Council in accordance with the provisions of Article 5

O "Relevant Position" shall be defined and interpreted as follows:

(i) A vehicle shall be regarded as displaying a permit, ticket or disc as the case may be in the relevant position when:

(ii) In the case of a vehicle fitted with a front windscreen the permit, ticket or disc is exhibited on the near side of the vehicle immediately behind the windscreen so as to be legible from outside the vehicle; or

(iii) In the case of a vehicle not fitted with a front windscreen the permit, ticket or disc is exhibited in a conspicuous position on the vehicle so as to be easily legible from outside the vehicle.

(iv) In the case of a disabled person's badge when either:

(v) In the case of a vehicle fitted with a dashboard or a facia panel the badge is exhibited thereon so that Part I of the badge is legible from outside the vehicle; or

(vi) In the case of a vehicle not fitted with a dashboard or facia panel the badge is exhibited in a conspicuous position on the vehicle so that Part I of the badge is legible from outside the vehicle

(vii) In ALL cases: so that the details displayed thereon are clearly visible from outside the vehicle.

(ii) The Interpretation Act 1979 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament and as if for the purpose of Section 38 of that Act this Order were an Act of Parliament and the Order revoked by Article 1 of this Order were an Act of Parliament hereby repealed

PART II

3 Use of Parking Places

Each area of land specified in column 1 of the Schedule to this Order may be used subject to the following provisions of this Order as a parking space during the prescribed hours for such classes of vehicle on such days and on payment of such charges as are specified in relation to that parking place in the said Schedule

- 3.1 The Council may close a parking place or any part thereof, for such periods and on such conditions as it shall think fit without notice.
- 3.2 The exercise by the Council of their powers under this Order shall not render them subject to any liability in respect of the loss of, or damage to, any vehicle parking in the parking place, howsoever, caused.

4. Class and Position of Vehicle

Where in the Schedule to this Order a parking place is described as available for a vehicle of a specified class or in a specified position the driver of a vehicle shall not permit it to wait in that parking place unless it is:

- (a) of the specified class appropriate to that parking place
or
- (b) in a position other than specified for that parking place

- 4.1 The driver of a vehicle shall not permit it to wait in any parking place in a space or bay marked as available for disabled persons unless the vehicle displays a valid disabled persons badge along with a valid time clock.
- 4.2 The driver of any vehicle exceeding 1500 kg unladen weight shall not permit that vehicle to wait in any parking place, at any time.

5. Charges for Use of Parking Places

- (i) The driver in the vehicle waiting in a parking place shall pay the appropriate charge per visit in accordance with the Scale of Charges specified in column 4 of the Schedule to this Order
- (ii) The driver of a vehicle not being a vehicle exempted in Article 13 of this Order using a parking place during the prescribed hours shall on leaving the vehicle in the parking place pay the appropriate charge in accordance with the Scale of Charges specified in column 4 of the Schedule to this Order
- (iii) The charge referred to in the last proceeding paragraph shall be payable by the insertion of an appropriate coin or coins in the ticket machine
- (iv) The driver of a vehicle shall attach any ticket issued on payment of the charges referred to in this Article in a conspicuous position on the vehicle in respect of which it was issued and shall cause the said ticket to be exhibited in that position at all times while the vehicle is parked in the parking place

- (v) Where any ticket machine is defective or is not installed on a car park the appropriate charge may be collected by a car park attendant who will thereupon issue a ticket indicating the charge paid and the time and date of issue or use another ticket machine to obtain a ticket if necessary from a different car park.
- (vi) The owner of a vehicle may apply to the Council and the Council may at its discretion and at a fee to be determined by it issue a contract which shall be valid for the parking place and for the period for which it is issued and the Council may restrict the sale of contracts as it sees fit.
- (vii) The Council operates short stay car parks, when the maximum permitted stay has exceeded, a driver is not permitted to return to the said car park within 2 hours.
- (viii) Council car parks will be operational 7 days per week, including bank holidays.
- (ix) The charges for Council car parks may be in operation between 8am and 8pm.

6 Penalty Charge

If a vehicle is left in a parking place for a period longer than that for which payment has been made in accordance with the Scale of Charges specified in column 4 of the Schedule to this Order or does not park the vehicle within designated parking bays or does not display a ticket in accordance with Article 5 thereof or exceeds the maximum permitted stay specified in Column 4 of the Schedule to this order or the driver shall pay Penalty charge of £60.00 within 28 days. However provided that payment of the charge reaches the Council's Finance Director by 10.00 am on the 14th day following the date on the Notice to pay the Penalty charge it will be reduced to £30.00.

7 Notice of Penalty Charge Incurred

In the case of a vehicle in respect of which an Penalty charge may have been incurred it shall be the duty of a parking attendant to attach to the vehicle in a conspicuous position a notice which shall include the following particulars

- (a) the registration mark of the vehicle
- (b) excise licence number
- (c) make of vehicle
- (d) colour of vehicle
- (e) detailed location of vehicle
- (f) contravention code and description of contravention
- (g) the time he notices that the charge has been incurred
- (h) time of issue
- (i) date
- (j) PCN number
- (k) attendants name
- (l) attendants signature
- (g) a statement that a Penalty charge of £60.00 is required to be paid within 28 days or £30.00 if payment of the charge reaches the Council's Finance Director by 10.00 am on the 14th following the date on the Notice to pay the Penalty charge

- (d) the manner in which and the time within which the charge should be paid and
- (e) a statement that it is an offence under this Order and subsection (4) of section 35 of the Road Traffic Regulation Act 1984 for the driver of a vehicle who has left the vehicle in a parking place to fail duly to pay the Penalty charge

8 Penalty Charge and Payment

- (a) Where a vehicle either:
 - (i) waits, parks or is left on an off street parking place in contravention of the provision of this Order, or otherwise contravenes or fails to comply with the provisions of this Order insofar as it relates to a vehicles waiting, parking or being left on an off street parking place, or
 - (ii) parks in contravention of the provisions of Section 19 or 21 of the Road Traffic Act 1988.

then a Penalty Charge shall be payable.

In the case of a vehicle in respect of which a Penalty Charge is payable under either paragraph (a) (i) or paragraph (a) (ii) of this Article, a Penalty Charge Notice may be issued by a Parking Attendant in accordance with the requirements of Section 66 of the Road Traffic Act 1991.

- (b) A Penalty Charge Notice shall contain the details required by Section 66(3) of the Road Traffic Act 1991.
- (c) Where a Penalty Charge Notice has been issued the Penalty Charge shall be payable by the owner of the vehicle in respect of which that notice was issued in accordance with Section 66 of the Road Traffic Act 1991 of the scale set out in Section 6 of this Order.
- (d) Where a Penalty Charge is payable and has not been paid to the Council within 28 days of the date of issue of the Penalty Charge Notice the Council may serve a notice, in accordance with Section 66 and Schedule 6 of the Road Traffic Act 1991, on the person who appears to them to have been the owner of the vehicle when the alleged contravention occurred.

Manner of Payment of Penalty Charge

The driver of a vehicle in respect of which a Penalty Charge Notice has been incurred shall pay the charge to the Council either by cheque or Postal Order which shall be delivered or sent by post so as to reach the Finance Department of the Council within 28 days or 14 days (Clauses 6 and 7(c) relate) following the date of the Notice of the Penalty charge or in cash in person at the said Department not later than as aforesaid or by Credit/Debit card:

provided that if the said twenty eighth day or fourteenth day falls upon a day on which the said Department is closed the period within payment of the

charge shall be made to the Council shall be extended until 10.00 am on the next full day upon which the said Department is open.

9. Evidence of Offence

The particulars as to the times at which a ticket was obtained from a ticket machine specified on the ticket issued by a parking apparatus and affixed in accordance with the provisions of Article 5 (ii) and 5 (iv) of this Order shall be evidence of the particulars so specified

10. Maximum Period of Waiting

The driver of a vehicle should not permit it to wait in a parking place for longer than the maximum period permitted for waiting specified in column 4 of the Schedule to this Order in respect of that parking place

11. Restriction on Removal of Notices

Where a Notice has been attached to a vehicle in accordance with Article 7 of this Order no person not being a parking attendant or some other person duly authorised by the Council shall remove the notice from the vehicle until the vehicle is removed from the parking place

12. Restriction on Removal of Parking Tickets

When a parking ticket has been exhibited on a vehicle in accordance with the provisions of Article 5 of this Order no person shall remove the parking ticket from the vehicle until the vehicle is removed from the parking place

13. Exemption for Charges

Notwithstanding the provisions of Article 5 of this Order the following vehicles shall be exempt from the payment of any charge specified in this Order

- (i) an invalid carriage
- (ii) a vehicle issued to a disabled person by the Department of Health and Social Security in lieu of an invalid carriage
- (iii) a disabled person's vehicle which displays in the windscreen of the vehicle a disabled person's badge issued by any local authority in accordance with the provisions of the Disabled Person's (Badges for Motor Vehicles) Regulations 1975 or a badge having effect under those Regulations as if it were a disabled person's badge
- (iv) The driver of a motor cycle or of a pedal cycle which is left in a parking place in the position marked out or signed for such vehicles shall be exempt from any charge.

14. Driving in Parking Places

- (i) No person shall except with the permission of any person duly authorised by the Council drive any vehicle in a parking place other than for the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place
- (ii) No person shall use a parking place as a means of passage to proceed from one road to another

- (iii) Where in a parking place signs are erected or surface markings are laid for the purpose of
 - (a) indicating the entrance to or exit from the parking place
 - (b) indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place
 - (1) No person shall drive or cause or permit to be driven any vehicle so that it enters the parking place otherwise than by an entrance or leaves the parking place otherwise than by an exit or
 - (2) in a direction other than that specified as the case may be
- (iv) The driver of a motor vehicle using a car park shall not sound a horn or other similar instrument except when about to change the position of a vehicle in or to depart from the parking place

15 Engines to be Stopped

The driver of a motor vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the engine until when about to change the position of the vehicle in or to depart from the parking place

16. Vehicles to be Licensed and Insured

The driver of a vehicle shall not permit that vehicle to wait in a parking place unless the vehicle is licensed in accordance with the provisions of Section 1 of the Vehicle (Excise) Act 1971 and unless there is in relation to the use of the vehicle such policy of insurance as complies with the requirements of Part VI of the Road Traffic Act 1972. The vehicle must also have a valid MOT certificate.

17 Use of Vehicles in Parking Places

No person shall use a vehicle while it is in a parking place in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire or reward of his skill or service (except with the prior permission of the Council)

17.1 No person shall use a parking place, or any vehicle thereon, in connection with any form of advertising, except with the prior written permission of the Council.

17.2 All vehicles must be parked wholly within an individually marked bay on the car park or in the parking place.

18 Conduct of Persons in Parking Places

- (i) No person shall in a parking place wantonly shout or otherwise make any loud noise in the disturbance or annoyance of users of the parking place or residents of premises in the neighbourhood
- (ii) No person shall in a parking place use any threatening abusive or insulting language gesture or conduct with intent to put any person in fear or so as to occasion a breach of the peace whereby a breach of the peace is likely to be occasioned

- (iii) No person shall use any part of a parking place or any vehicle left in a parking place
 - (a) for sleeping or camping purposes
 - (b) for eating or cooking purposes for any domestic or sanitary purposes
 - (c) for the purpose of repairing maintaining servicing or washing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to depart from the parking place
- (iv) No person shall in a parking place
 - (a) cause erect or permit to be erected any tent booth stand building or other structure without the written consent of the Council
 - (m) light or cause or permit to be lit any fire
 - (n) deposit or abandon any litter or together object except with prior permission from the Council

19 Movement of Vehicles in a Parking Place in Emergencies

- (i) A parking attendant or any other person duly authorised by the Council may move or cause to be moved in case of emergency to any place he thinks fit vehicles left in a parking place
- (ii) Where a vehicle is left in a parking place in a position other than specified in column 2 of the Schedule to this Order a parking attendant or any other person duly authorised by the Council may move the vehicle or cause it to be moved. to a position which complies with that specified in column 2 of the said Schedule

20 Removal of Vehicles from Parking Places

Where a parking attendant or any other person duly authorised by the Council is of the opinion that any of the provisions contained in this Order have been contravened or not complied with in respect of a vehicle left in a parking place he may remove that vehicle or cause it to be removed from the parking place

21 Manner of Moving Vehicles

Any person moving or removing a vehicle in accordance with Article 19 or 20 of this Order may do so by towing or driving the vehicle or in such other manner as he may think necessary and may take such measures in relation to the vehicle as he may think necessary to enable him to move or remove it as aforesaid

- 22 When a parking attendant or other person duly authorised by the Council removes a vehicle or causes it to be removed from a parking place in accordance with Article 20 of this Order he shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle but neither he nor the Council shall be liable for any damage which the vehicle may sustain in the course of such removal

23 Power to Suspend Use of Parking Places

Any person duly authorised by the Council or a Police Officer on duty to suspend the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary See section 37.

24 Incorporation of Enactments

Sub-sectioned (4) (5) (6) and (7) of Section 47 of *the Act* shall apply to the parking places as if they were parking places provided on a highway

PART III

25 Disposal of Vehicles Abandoned in Parking Places

The Council may as respects a vehicle which has been or could at any time be removed from a parking place in pursuance of Article 10 of this Order if it appears to them to have been abandoned sell or otherwise dispose of the vehicle

Provided that the power of disposal conferred by this Article shall not be exercisable in the case of a vehicle unless there have been taken by the Council such of the following steps as are applicable to the vehicle and there has elapsed a period of six weeks beginning with the taking of the first of those steps

- 26 (1) Subject to the provisions of Article 32 of this Order where a vehicle carried a registration mark issued under the Vehicles (Excise) Act 1971 the Council shall apply in writing to the Council with whom they have reason to believe the vehicle was last registered inquiring who it appears may be the owner of the vehicle and the address of that person
- (2) Where the Council act under this Article the first steps for the purpose of the last and the next succeeding Article shall be taken to be the sending of the notice mentioned in Article 27
- 27 The Council shall where they are by virtue of the last preceding Article aware of the name and address of a person who it appears may be the owner of the vehicle send a notice to that person at the address stating that it is the intention of the Council to sell or otherwise dispose of the vehicle (which shall be sufficiently described in the notice) on or after a specified date (which shall not be less than two weeks from the date of the notice and in any event not earlier than six weeks from the date of the first step taken by the Council under this Part of this Order) unless it is in the said notice or from such place as may be subsequently notified in writing by the Council to that person
- 28 If any person to whom a notice is sent in accordance with the last preceding Article informs the Council that they no longer owns the vehicle they must provide evidence to show that he or she had sold the vehicle by the time the parking contravention in question took place. Along with the name and address of the buyer.
- 29 Subject to the provisions of Article 28 of this Order where a vehicle does not carry a registration mark issued under the Vehicles (Excise) Act 1971 the first step to be taken by the Council shall be to apply in writing to the Chief Officer of the Police Force in whose area is the parking place from which the vehicle has been or could at any time be remove in pursuance of this Order inquiring who that Officer considers is the owner of the vehicle and the address of that person

- 30 If after steps have been taken under the foregoing provisions of this Part of this Order a vehicle is not claimed the Council shall make further inquiries (if any) as they consider reasonable as to who may be the owner of the vehicle and the address of that person
- 31 Where by virtue of Article 29 or 30 of this Order the Council are informed of the name and address of a person who it is considered may be the owner of the vehicle Article 27 and 28 of this Order as respects the sending of notices shall apply in relation to that person at that address as they apply in relation to the person mentioned in the said Article 26
- 32 Nothing in the foregoing provisions of this Part of this Order shall require the Council to take any such steps as in therein mentioned for the purpose of inquiring who is the owner of a vehicle to which Article 25 of this Order applies if they have found a person who satisfied them that he is in fact the owner of that vehicle and they have sent him at that address a notice containing the particulars specified in Article 27 of this Order the sending of this notice being treated as the first step for the purpose of that Article and the said Article 25.
- 33 Upon the sale of a vehicle by the Council the Council shall apply the proceeds of sale in or towards the satisfaction of any costs incurred by them in connection with the disposal thereof and of any charge to payment of which they are entitled as regards , the vehicle under Section 102 of the 1984 Act
- 34 In the event of any such costs incurred by them in connection with the disposal of the vehicle not being satisfied by virtue of the last preceding Article the Council may recoup those costs as far as not satisfied from the person who was the last owner of the vehicle before it was removed from the parking place either in pursuance of 20 of this Order or after it had been disposed of by virtue of the power of disposal conferred by Article 25 of this Order except in a case where that person satisfied the Council that he was not responsible for the vehicle being in the place from which it was removed and in that case the person by whom the said costs shall be payable shall be the person driving the vehicle at the time the vehicle was left in that place
- 35 Any sums received by the Council on a sale of the vehicle after deducting any sum applied thereabouts by virtue of Article 33 of this Order shall be payable within a period of one year from the date of the sale of the vehicle to any person to whom but for such sale the vehicle would have belonged and if so far as any such sums are not claimed within the said period they shall be paid into the general rate fund of the Council
- 36 Where under the foregoing provisions of this Part of this Order a notice is required to be or may be sent to a person the despatching of such a notice by registered post or by the recorded delivery service shall be sufficient compliance with such provisions without proof of delivery.
- 37 Where under any circumstances a car park must be closed of an Emergency the Council is required to give no such notice, however if a car park is to be

closed and thus removed from the order a 28 day waiting period would then come in to force.
