

**The County of Cornwall (Bodmin) (Various Streets)
(Restrictions on Waiting) (Amendment) Order 2021**

Cornwall Council in exercise of its powers under Section 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the *8th of August* 2022 and may be cited as 'The County of Cornwall (Bodmin) (Various Streets) (Restrictions on Waiting) (Amendment) Order 2021'.

2. The County of Cornwall (Bodmin) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

Article 3.2.5 was deleted and replaced with the following:

3.2.5 Between the hours of 9am and 6pm Monday to Saturday (both days inclusive) in the lengths of road specified in the Twenty-Third Schedule to this Order –

- (i) for a longer period than 2 hours; or
- (ii) if a period of less than 4 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in that length of road.
