The County of Cornwall (Bodmin) (Rhind Street) (On Street Parking Places and Restrictions on Waiting) (Amendment) Order 2021

Cornwall Council in exercise of its powers under Section 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

In the First Schedule relating to No waiting at any time:

Paragraph 25(c) was deleted and replaced with the following:

- 25. Dennison Road (A0389)
- (c) north sidefrom its junction with Church Square to a point 18metres west of its junction with Berrycoombe Road
- (d) south sidefrom its junction with Church Square to a point 34metres west of its junction with Chapel Lane

Paragraph 51(b)(iii) & (iv) were deleted and replaced with the following:

- 51. Rhind Street (U6131)
- (b) south-east side
- (iii) from its junction with Dennison Road to a point 1 metre north-east of the south-western building boundary of Nos 9-12
- (iv) from a point 4 metres south-west of the northeastern boundary of Nos 17-20 to the southwestern boundary of No 34
- (v) between points 7 metres south-west and 3 metres north-east of the north-eastern boundary of No 34a

In the Eighteenth Schedule relating to Limited waiting Mon-Sat 9am-5pm 1 hour no return within 2 hours:

Paragraph 1 was deleted and replaced with the following:

1. Rhind Street (U6131)

south-east side from a point 1 metre north-east of the southwestern building boundary of Nos 9-12 to a point 4 metres south-west of the north-eastern boundary of Nos 17-20

In the Twentieth Schedule relating to No loading at any time:

The paragraph relating to Dennison Road was deleted and replaced with the following:

Dennison Road (A0389) (a) north side from its junction with Church Square to a point 18 metres west of its junction with Berrycoombe Road

 from its junction with Church Square to a point 34
 metres west of its junction with Chapel Lane
