#### The County of Cornwall (Infra24-269) (Bodmin) (Turf Street) (Restrictions on Waiting) (Experimental) Order 2025

THE CORNWALL COUNCIL in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 7<sup>th</sup> day of March 2025 for a period of 18 months (to 6<sup>th</sup> September 2026) and may be cited as "The County of Cornwall (Infra24-269) (Bodmin) (Turf Street) (Restrictions on Waiting) (Experimental) Order 2025".

2. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:

"enactment" means any enactment whether public, general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

"Map Schedules" means the plans, including their keys, annexed to The County of Cornwall (East Central Cornwall) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2024; and

"Map Tiles" means the plans, including their keys, contained in the Schedule to this Order.

3. Unless expressly stated to the contrary, any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated or reenacted by, or as having effect by virtue of, any subsequent enactment.

4. Save as provided in Article 5, the Map Schedules are hereby varied to the extent shown on the Map Tiles.

5. Any existing prohibitions, restrictions or designations applying to any lengths of road or sides of any lengths of road prior to this Order coming into force, which are not referenced on the Map Tiles, shall be deemed to be excluded from the aforementioned variation.

6. In so far as any provision of this Order conflicts with any provision of any Order previously made or having effect as if it were previously made under the Act of 1984 and which imposes a restriction or prohibition on vehicles or grants an exemption from such restriction or prohibition then that provision of this Order shall prevail.

7. Except where provided by Article 6, the prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether made under the Act of 1984 or otherwise.

8. The Head of Highways and Infrastructure at Cornwall Council, or a person authorised by him, may modify or suspend the operation of this Order or any provision of it, if it appears to him essential:-

- i. in the interests of the expeditious, convenient and safe movement of traffic;
- ii. in the interests of providing suitable and adequate on-street parking facilities; or
- iii. for preserving or improving the amenities of the area through which any road affected by the Order runs.


