

**The County of Cornwall (Bodmin) (Various Streets)
(Restrictions on Waiting) (Amendment) Order 2019**

Cornwall Council in exercise of its powers under Sections 1, 32 and 35 (and Part IV of Schedule 9) of the Road Traffic Regulation Act 1984 (hereinafter referred to as ‘the Act of 1984’) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the 15th day of July 2020 and may be cited as “The County of Cornwall (Bodmin) (Various Streets) (Restrictions on Waiting) (Amendment) Order 2019”.
2. The County of Cornwall (Bodmin) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

In Article 3.2.7 beginning ‘between the hours of 8am and 4pm...’ the Article reference was deleted and replaced with reference 3.2.8. Also, in the opening paragraph the words ‘Twenty-Fifth’ were deleted and replaced with the words ‘Twenty-Sixth’.

In the First Schedule relating to No waiting at any time:
