The County of Cornwall (Crooklets) (Bude) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2023

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

- 1. This Order shall come into force on the 21st day of February 2024 and may be cited as "The County of Cornwall (Crooklets) (Bude) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2023".
- 2. The County of Cornwall (Bude) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:

After Article 3.1.7 the following new Article was inserted:

3.1.8 between 1st March to 30th September (both dates inclusive) in the lengths of road specified in the Sixteenth Schedule to this Order.

In Article 4 the word 'Waiting' was deleted.

In Article 4.1 the words 'Article 3' were deleted and replaced with the words 'Articles 3 and 5A'.

After Article 5 the following new Article was inserted:

5A.2.1 between 8pm on any day and 6am the following day, on any of the lengths of road specified in the Seventeenth Schedule to this Order.
