Cornwall County Council in exercise of its powers under Sections 1, 2, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. The Order shall come into force on the day of 2007 and may be cited as "The County of Cornwall (St.Austell) (Various Streets) (On-Street Parking Restrictions on Waiting) (Consolidation) Order 2005 (Amendment No.4) Order 2006"
- 2. The County of Cornwall (St.Austell) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

In Article 2.1.3 the words "Fourteenth Schedule" were deleted and replaced with the following:

"Fourteenth and Sixteenth Schedules"

After Article 4.8 the following was inserted –

4.9 Nothing in Article 3 shall apply to any official wedding vehicles if they cannot conveniently be used for such purposes in any other road, while in use in connection with a wedding ceremony being held at premises situated on or adjacent to the said length of road

In Article 5.1 the words "Fourteenth Schedule" were deleted and replaced with the following:

"Fourteenth and Sixteenth Schedules"

In the Second Schedule:

(U6106) from its junction with Market Street to its junction with High

Cross Street

Paragraph 66 relating to Market Street was deleted and substituted for the following:-

Market Street both sides

from its junction with Church Street to its junction with

Trevarthian Road

Paragraph 106 relating to Trevarthian Road the following was inserted: -

Trevarthian Road both sides

(U6106) from its junction with Market Street to its termination at the

railway bridge including the turning head adjacent to the

railway bridge.

The following was inserted at the end of the Second Schedule:-

Trevail Way (Unadopted)

(a) east side

from its junction with Carlyon Road for a distance of 29

metres in a southerly direction

(b) west side

from its junction with Carlyon Road for a distance of 28

metres in a southerly direction
