

THE COUNTY OF CORNWALL (FOWEY) (VARIOUS STREETS)
(ON-STREET PARKING PLACES AND RESTRICTIONS ON WAITING) (CONSOLIDATION)
ORDER 2005
(AMENDMENT NO. 1) ORDER 2007

Cornwall County Council in exercise of its powers under Sections 1, 2, 32 (1) and 35 (1) of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the day of 2007 and may be cited as "The County of Cornwall (Fowey) (Various Streets) (On-Street Parking Restrictions on Waiting) (Consolidation) Order 2005 (Amendment No.1) Order 2007"

2. The County of Cornwall (Fowey) (Various Streets) (On-Street Parking Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

In Article 2 the following was inserted –

2.1.16 – **"solo motor cycle"** as defined in Section 136 of the Act of 1984.

Article 8 and subsequent paragraphs were re-numbered as Article 9

Article 9 and subsequent paragraphs were re-numbered as Article 10

After Article 7 there was inserted the following –

8. Solo Motorcycle Parking Place

8.1 The area of highway specified in the Ninth Schedule to this Order is authorised to be used, subject to the following provisions of this Order, as a parking place for the leaving of:-

- (i) such classes of vehicle and in such positions as are specified in Article 8.2.
- (ii) on such days and during such hours as is Specified in the Ninth Schedule to this Order

8.2 No person shall cause or permit a vehicle to wait in the parking place specified in the Schedule unless -

8.2.2 – It is a solo motor-cycle as defined in Article 2.1.7.

8.2.3 – It is wholly within the limits of the parking place.

The following was inserted in Paragraph 17 relating to Polvillion

1. Polvillion Road (A3082) south side
from its junction with Windmill for a distance of 26 metres in a westerly direction

Paragraph 28 was deleted and substituted for the following –

2. Windmill (U6143)
 - (a) east side
 - (i) from its junction with New Road Hill for a distance of 9 metres in a southerly direction
 - (ii) from a point 78 metres south-east of its junction with New Road Hill for a distance of 160 metres in a southerly direction
 - (b) west side
 - from its junction with Polvillion Road for a distance of 50 metres in a southerly direction

After the Eighth Schedule the following was inserted –

Ninth Schedule
Parking Place for Solo Motor-Cycles
30 minutes (no return within 1 hour)

1. Unnamed Street Leading To Town Hall (U6143) north side
from a point 2 metres east of its junction with South Street for a distance of 3 metres in an easterly direction and having a width throughout of 2 metres
