## THE COUNTY OF CORNWALL (HAYLE) (VARIOUS STREETS) (ON-STREET PARKING PLACES AND RESTRICTIONS ON WAITING) (CONSOLIDATION) ORDER 2005 (AMENDMENT NO. 2) ORDER 2008

Cornwall Council in exercise of its powers under Sections 1 and 2 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 2. The County of Cornwall (Hayle) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2008 shall have effect as though:

Article 3.1.5 relating to the Fifth Schedule is hereby deleted

The Fifth Schedule No Waiting Mon – Sat is hereby deleted

Paragraph 21(b) in the First Schedule relating to "No Waiting At Any Time" shall be deleted and replaced with the following:

Guildford Road

(C0286)

- (b) south-west side

from its junction with Penmare Terrace to its junction with

Trelee Close

The following was inserted in paragraph 21(a) in the First Schedule:

21. Guildford Road

(C0286)

- (a) north-east side

(ii) from a point 21m north-west of its junction with Marsh

Lane to its junction with Philgray Close

The following was inserted in the First Schedule:

Philgray Close

(U6033)

- north side -

from its junction with Guildford Road for a distance of 8m

in an easterly direction.

Trelee Close

(U6019)

- north side -

from its junction with Guildford Road for a distance of 5m

in a westerly direction
