

THE COUNTY OF CORNWALL (ILLOGAN HIGHWAY & POOL) (VARIOUS STREETS) (ON-STREET PARKING PLACES AND RESTRICTIONS ON WAITING) (CONSOLIDATION) ORDER 2005 (AMENDMENT NO.1) ORDER 2006

CORNWALL COUNTY COUNCIL in exercise of its powers under Sections 1 and 2 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

1. This Order shall come into force on the 29th day of September 2006 and may be cited as "The County of Cornwall (Illogan Highway & Pool) (Various Streets) (On-street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 (Amendment No.1) Order 2006"
2. The County of Cornwall (Illogan Highway & Pool) (Various Streets) (On-street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

(a) In the First Schedule thereto -

(i) paragraph 20 was renumbered 21;

(ii) paragraphs 21 to 25 inclusive were renumbered 23 to 27 respectively;

(iii) the following paragraph was inserted immediately after paragraph 19 -

"20. Treloweth Road
(U6042)

- (a) north-east side
 - (i) from its junction with Fore Street for a distance of 13m in a north westerly direction;
 - (ii) from its junction with Cort Simmons for a distance of 10m in a southerly direction;
- (b) south-west side
 - from its junction with Fore Street for a distance of 9m in a north westerly direction;
- (c) south-east side
 - from its junction with Cort Simmons for a distance of 10m in a north easterly direction";

(iv) the following paragraph was inserted immediately after paragraph 20 -

"22. Trevithick Road
(U6042)

- both sides
 - from its junction with Agar Road for a distance of 10m in a northerly direction";

(v) the following paragraph was inserted immediately after paragraph 25

"28. Wheal Fortune Lane
(U6043)

- (a) east-side
 - from its junction with Agar Road for a distance of 24m in a northerly direction;
- (b) west-side
 - from its junction with Agar Road for a distance of 23m in a northerly direction";

- (b) in the sixth schedule thereto -
paragraph 1 (relating to Chariot Road) were deleted.
