

**The County of Cornwall (Illogan Highway and Pool) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005
(Amendment No. 2) Order 2007**

Cornwall County Council in exercise of its powers under Sections 1 and 2 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the 25th day of February 2008 and may be cited as "The County of Cornwall (Illogan Highway and Pool) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 (Amendment No. 2) Order 2007"

2. The County of Cornwall (Illogan Highway and Pool) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

In the First Schedule – No Waiting at Any Time:-

There were included the following:-

| Barncoose Roundabout | - All sides For its entire length |
| Barncoose Roundabout north-western spur | - Both sides from its junction with Barncoose Roundabout for a distance of 35 metres in a north-westerly direction |
| Barncoose Roundabout south - western spur | - Both sides from its junction with Barncoose Roundabout for a distance of 13 metres in a south-westerly direction |
| Road between Barncoose Roundabout and Barncoose Mini Roundabout | - Both sides for its entire length |
| Barncoose Mini Roundabout | - Western side for its entire length |
| Barncoose Mini Roundabout Northern Spur | - Western side from its junction with Barncoose Mini Roundabout for a distance of 7 metres in a |

- northerly direction
- Barncoose Mini Roundabout southern spur - Both sides from its junction with Barncoose Mini Roundabout for a distance of 14 metres in a southerly direction
- Barncoose Terrace (A3047) - North side from a point 142 metres east to a point 64 metres west of its junction with Lower Barncoose
- South side from its junction with the road leading to Carn Brea Village for a distance of 208 metres in a westerly direction
- Lower Barncoose (U6046) - North-west side from its junction with Barncoose Terrace for a distance of 43 metres in a north-easterly direction
- South-east side from its junction with Barncoose Terrace for a distance of 19 metres
- Wilson Way - For its entire length

In the Second Schedule – No Waiting 8am – 6pm:-

Paragraph 1 was deleted and replaced with the following:-

- Barncoose Terrace (A3074) - North side
- (i) from a point 142 metres east of its junction with Lower Barncoose for a distance of 96 metres in an easterly direction
- (ii) from a point 64 metres west of its junction with Lower Barncoose to a point 8 metres north-east of its junction with Crembing Well
- South side
- (i) from its junction with the road leading to Carn Brea Village to its junction with Blowinghouse Hill
- (ii) from a point 208 metres west of its junction with the road leading to Carn Brea Village to a point 84 metres north-east of its junction with Barncoose Lane
