

THE COUNTY OF CORNWALL (MEVAGISSEY) (VARIOUS STREETS)  
(ON-STREET PARKING PLACES AND RESTRICTIONS ON WAITING)  
(CONSOLIDATION) ORDER 2005  
(AMENDMENT NO.1) ORDER 2008

Cornwall County Council in exercise of its powers under Sections 1, 2, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the 11<sup>th</sup> day of February 2009 and may be cited as “The County of Cornwall (Mevagissey) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 (Amendment No.1) Order 2008”
2. The County of Cornwall (Mevagissey) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

In the Third Schedule relating to 'no waiting at any time':-

Paragraph 7 (v) was deleted and substituted with the following:-

- Cliff Street (U6101)
- (a) east side
- (v) from a point 10 metres north to a point 31 metres south of its junction with Battery Terrace

Paragraph 24 was deleted and substituted with the following:-

- Tregoney Hill  
(C0009)
- (a) south side:-
- (i) from its junction with Fore Street to a point 153 metres east of a point opposite its junction with Lamorak Close
- (ii) from a point 144 metres east of a point opposite its junction with Lamorak Close for a distance of 28 metres in an westerly direction
- (iii) from a point 105 metres east of a point opposite its junction with Lamorak Close for a distance of 26 metres in an westerly direction
- (iv) from a point 67 metres east of a point opposite its junction with Lamorak Close for a distance of 34 metres in an westerly direction
- (v) from a point 17 metres east of a point opposite its junction with Lamorak Close for a distance of 36 metres in an westerly direction
- (b) north side:-
- (i) from its junction with Fore Street to a point 137 metres east of its junction with Lamorak Close

(ii) from a point 121 metres east of its junction with Lamorak Close for a distance of 25 metres in a westerly direction

(iii) from a point 82 metres east of its junction with Lamorak Close for a distance of 32 metres in a westerly direction

(iv) from a point 39 metres east to a point 14 metres west of its junction with Lamorak Close

The following was inserted:-

Lamorak Close (a) Both sides  
(U6101)

From its junction with Tregoney Hill for a distance of 16 metres in a northerly direction

In the Forth Schedule relating to 'no waiting between 01 Apr and 30 Sep:-

Paragraph 5 was deleted.
