

THE COUNTY OF CORNWALL (ST.IVES) (VARIOUS STREETS)
(ON-STREET PARKING PLACES AND RESTRICTIONS ON WAITING) (CONSOLIDATION)
ORDER 2007 (AMENDMENT NO. 3) ORDER 2007

Cornwall Council in exercise of its powers under Sections 1, 2, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the 20th day of November 2009 and may be cited as "The County of Cornwall (St.Ives) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2007 (Amendment No.3) Order 2007"

2. The County of Cornwall (St.Ives) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:

In Article 4.2 (c) after the word "vehicle" the following was inserted

"provided that, except as specified in paragraph (b) above, no vehicle shall so wait at any time in the lengths of road specified in the Thirteenth Schedule of this Order;"

In Article 4.7 after the words "in the same length of road)," the following was inserted:

"provided that such period lies within the period during which the exemption as to loading and unloading specified in paragraph (c) of Article 4.2 of this Order applies."

In the First Schedule relating to no waiting at any time, paragraph 84 was deleted and replaced with the following:

84. Tregenna Place (B3306)
- (a) west side
 - (i) from its junction with Gabriel Street for a distance of 20 metres in a northerly direction
 - (ii) from its junction with Bedford Road for a distance of 19 metres in a southerly direction
 - (b) east side
 - for its entire length

In the Tenth Schedule relating to Loading Bay at any time, the following was inserted –

3. Tregenna Place (B3306) - west side
- from a point 20 metres north of its junction with Gabriel Street to a point 19 metres south of its junction with Bedford Road

After the Twelfth Schedule the following was inserted –

THIRTEENTH SCHEDULE

No Loading at any time

- Tregenna Place (B3306)
- (a) west side
 - (i) from its junction with Gabriel Street for a distance of 20 metres in a northerly direction

- (ii) from its junction with Bedford Road for a distance of 19 metres in a southerly direction
- (b) east side
for its entire length
