

THE COUNTY OF CORNWALL (ST JUST) (VARIOUS STREETS) (ON-STREET
PARKING PLACES AND RESTRICTIONS ON WAITING) (CONSOLIDATION)
ORDER 2006 (AMENDMENT NO.1) ORDER 2008

Cornwall County Council in exercise of its powers under Sections 1, 2, 32 and 35 (and Part IV of Schedule 9) of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the 7th day of November 2008 and may be cited as "The County of Cornwall (St Just) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2006 (Amendment No.1) Order 2008"

2. The County of Cornwall (St Just) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2006 shall have effect as though:

In the first schedule relating to no waiting at any time, the following was inserted:

Carn Bosavern
(A3071)

- (a) north side
from a point 17 metres south of its junction with Fore Street to its junction with the un-named access road to the rear of 7-40 Carn Bosavern
- (b) south side
 - (i) from its junction with South Place for a distance of 77 metres in a south-easterly direction.
 - (ii) from a point 116 metres south-east of its junction with South Place for a distance of 13 metres in a south-easterly direction.
 - (iii) from a point 147 metres south-east of its junction with South Place for a distance of 11 metres in a south-easterly direction.
 - (iv) from a point 166 metres south-east of its junction with South Place for a distance of 12 metres in a south-easterly direction.
 - (v) from of point 194 metres south-east of its junction with South Place for a distance of 8 metres in a south-easterly direction.
 - (vi) from a point 250 metres south-east of its junction with South Place for a distance of 10 metres in a south-easterly direction.

In the third schedule relating to limited waiting Monday – Friday, 8am – 5pm, 30 minutes no return within 2 hours, the following was inserted:

Carn Bosavern
(A3071)

South side

(i) from a point 77 metres south-east of its junction with South Place for a distance of 39 metres in a south-easterly direction.

(ii) from a point 202 metres south-east of its junction with South Place for a distance of 48 metres in a south-easterly direction.
