

THE COUNTY OF CORNWALL (ST.IVES) (VARIOUS STREETS)
(ON-STREET PARKING PLACES AND RESTRICTIONS ON WAITING)
(CONSOLIDATION) ORDER 2007
(AMENDMENT NO. 5) ORDER 2008

Cornwall Council in exercise of its powers under Sections 1, 2, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

1. The Order shall come into force on the 30th day of July 2010 and may be cited as "The County of Cornwall (St. Ives) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2007 (Amendment No. 5) Order 2008"

2. The County of Cornwall (St. Ives) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:

In the First Schedule the following paragraphs were inserted:

Road to the rear of 1-6 Albert Place (U6014)	both sides for its entire length
Corva Road (U6014)	both sides from its junction with Porthia Road for a distance of 12 metres in a north-westerly direction.
Porthia Road (U6014)	(a) both sides (i) from a point 23 metres south-west of its junction with Corva Road to a point 21 metres north-east of that junction. (ii) from a point 12 metres south-west of its junction with Porthia Close to a point 10 metres north-east of that junction.
Porthia Close (U6014)	(a) north-east side from its junction with Porthia Road for a distance of 10 metres in a south-easterly direction. (b) south-west side from its junction with Porthia Road for a distance of 15 metres in a south-easterly direction.
Trelawney Avenue (U6013)	(a) north side from a point 10 metres east to a point 15 metres south-west of its junction with Carnellis Road. (b) south side from a point 12 metres east to a point 10 metres south-west of its junction with Carnellis Road.
