## THE COUNTY OF CORNWALL (CARBIS BAY) (VARIOUS STREETS) (RESTRICTIONS ON WAITING) (CONSOLIDATION) ORDER 2005 (AMENDMENT NO. 1) ORDER 2008

Cornwall Council in exercise of its powers under Sections 1, 2, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

- 1. The Order shall come into force on the 30<sup>th</sup> day of July 2010 and may be cited as "The County of Cornwall (Carbis Bay) (Various Streets) (Restrictions on Waiting) (Consolidation) Order 2005 (Amendment No. 1) Order 2008"
- 2. The County of Cornwall (Carbis Bay) (Various Streets) (Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

After Article 3.1.4 the following was inserted

- 3.1.5 between 1<sup>st</sup> April and 30<sup>th</sup> September (both dates inclusive) in the lengths of road specified in the Sixth Schedule to this order.
- 1. In the First Schedule, the following was inserted:

9. Polmennor Drive Spur Road Leading to the School (U6014) both sides

from its junction with Polmennor Drive to its termination at St Uny School gates.

2. The following Schedule was added:

## SIXTH SCHEDULE No Waiting between 1<sup>st</sup> April and 30<sup>th</sup> September

1. Boskerris Road

(U6016)

both sides

from its eastern junction with Boskerris Crescent to its junction with Boskerris Road north-west spur

2. Boskerris Road (north western spur)

(U6016)

north-east side

from its junction with Boskerris Road for a distance

of 11 metres in a north-westerly direction

3. Boskerris Crescent (West entrance)

(U6016)

both sides

(i) from its junction with Boskerris Road for a distance of 10 metres in a southerly direction.

both sides

4. Boskerris Crescent (East entrance) (U6016)

(ii) from its junction with Boskerris Road for a distance of 10 metres in a southerly direction.
