

THE COUNTY OF CORNWALL (CARBIS BAY) (VARIOUS STREETS)
(RESTRICTIONS ON WAITING)
(CONSOLIDATION) ORDER 2005
(AMENDMENT NO. 1) ORDER 2008

Cornwall Council in exercise of its powers under Sections 1, 2, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order: -

1. The Order shall come into force on the 30th day of July 2010 and may be cited as "The County of Cornwall (Carbis Bay) (Various Streets) (Restrictions on Waiting) (Consolidation) Order 2005 (Amendment No. 1) Order 2008"

2. The County of Cornwall (Carbis Bay) (Various Streets) (Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

After Article 3.1.4 the following was inserted

3.1.5 between 1st April and 30th September (both dates inclusive) in the lengths of road specified in the Sixth Schedule to this order.

1. In the First Schedule, the following was inserted:
