

**The County of Cornwall (Liskeard) (Barras Street) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 (Amendment) Order 2010**

Cornwall Council in exercise of its powers under Sections 1, 2, 32 & 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the **9<sup>th</sup>** day of **March 2011** and may be cited as The County of Cornwall (Liskeard) (Barras Street) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 (Amendment) Order 2010

2. The County of Cornwall (Liskeard) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

In the First Schedule – No waiting at any time relating to Barras Street, paragraph b (i) is deleted and substituted with:-

Barras Street (C0266)	(b) (i)	west side from a point 19 metres south of a point opposite its junction with Pike Street to a point 11 metres north of its junction with Greenbank Road.

In the First Schedule relating to Barras Street, the following was added after paragraph (b)

Barras Street (C0266)	(ii)	west side from its junction with West Street to a point 22 metres north of its junction with Greenbank Road.

In the Tenth Schedule relating to West Street – Loading Bay at any time – the road name and paragraph was deleted and substituted with:-

Barras Street (C0266)	south-west side from a point 11 metres north-west of its junction with Greenbank Road for a distance of 11 metres in a north- westerly direction.
