THE COUNTY OF CORNWALL (ST IVES) (VARIOUS STREETS) (ON-STREET PARKING PLACES AND RESTRICTIONS ON WAITING) (AMENDMENT) ORDER 2010

Cornwall Council in exercise of its powers under Sections 1, 2, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. The Order shall come into force on the 28th day of March 2011 and may be cited as "The County of Cornwall (St Ives) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2010"
- 2. The County of Cornwall (St Ives) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:

In Articles 2.1.3 and 5.1 after the word "Eleventh" the word "Schedule" was deleted and substituted with: "and Fourteenth Schedules".

In Article 8.2 after the word "Twelfth" the following was inserted: "and Thirteenth".

In the First Schedule paragraphs 4(c) and 33 were deleted and substituted with the following:

from its junction with St Andrew's Street for a distance of 49 metres in an easterly direction

(b) south side

from its junction with Skidden Hill for a distance of 36 metres in an easterly direction

In the Fourth Schedule paragraph 1(a)(ii) was deleted and substituted with the following:

(a) northern side

(ii) from a point 12 metres east of its junction with Parc Bean Terrace to a point 19 metres west of its junction with the unnamed road from Orange Lane to Ventnor Terrace
