The County of Cornwall (Truro) (St.Dominic Street Area) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2010

Cornwall Council in exercise of its powers under Sections 1 and 2, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. The Order shall come into force on the 24th day of March 2011 and may be cited as "The County of Cornwall (Truro) (St.Dominic Street Area) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2010"
- 2. The County of Cornwall (Truro) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

In the Fifth Schedule - No waiting at any time

In the Paragraph relating to Bosvigo Road

Paragraph (a) was deleted.

The following was inserted into paragraph (b)

- (ii) from its junction with Kenwyn Street to a point 14 metres north-west of its junction with George Street.
- (iii) between points 19 metres north-west and 20 metres east of its junction with Richmond Place

The following was inserted into paragraph (c)

(iii) from its junction with Kenwyn Street for a distance of 46 metres in a north westerly direction.

In paragraph 91 relating to Kenwyn Street paragraph (c) was deleted and replaced with the following

South-side – from its junction with Calenick Street to a point 38 metres west of its junction with Little Castle Street.

In the paragraph relating to St.Dominic Street

Paragraph (a) and (b) were deleted and substituted for the following

- (a) north-east side from its junction with Ferris Town for a distance of 4 metres in a south-easterly direction.
- (b) South-west side for its entire length.

In the Sixth Schedule - No waiting 8am - 6pm

paragraph 5 relating to St.Dominic Street was deleted.

In the Eighth Schedule – no waiting Mon – Sat 8am – 6pm

In the paragraph relating to Bosvigo Road

Paragraph (a) was deleted and replaced with the following:-

- (a) north-east side
- (i) from a point 29 metres north-west of its junction with George Street for a distance of 5 metres in a north-westerly direction.
- (ii) from a point 41 metres north-west of its junction with George Street for a distance of 33 metres in a north-westerly direction

Paragraph (b) was deleted and replaced with the following:-

(b) south west side

from a point 46 metres north west of its junction with Kenwyn Street to its junction with Parkvedras Terrace.

In the paragraph relating to George Street paragraph (b) (iii) was deleted and substituted for the following:-

(b) (iii) from a point 36 metres south-east of its junction with Andrew Place in a south-easterly direction to its termination.

The paragraph relating to John Street was deleted and substituted for the following -

- (a) north-west side
- (i) from its junction with St.Georges Road for a distance of 16 metres in a south-westerly direction.
- (ii) from its junction with George Street for a distance of 7 metres in a north-easterly direction.
- (b) south-east side between its junction with St.Georges Road and George Street.

In paragraph 29 relating to Kenwyn Street paragraph (b) was deleted and replaced with

South-east side – from a point 24 metres east of its junction with City Road for a distance of 71 metres in an easterly direction.

The paragraph relating to St. Dominic Street was deleted.

The following was inserted in the Ninth Schedule

St.Georges Road – north-east side - between points 40 metres and 55 metres north-west of a point opposite its junction with John Street.

In the Twelfth Schedule relating to Limited Waiting Mon-Sat 8am-6pm 1 hour no return within 3 hours

The paragraph relating to Kenwyn Street section (b) was deleted and substituted with the following

(b) south-east side - from a point 5 metres north-east of its junction with City Road for a distance of 20 metres in a north-easterly

In the Thirteenth Schedule relating to Limited Waiting Mon-Sat 8am-6pm 1 hour no return within 2

Paragraph 2 relating to St.Dominic Square was deleted.
