

The County of Cornwall (Bodmin) (Fore Street and Honey Street) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2010

Cornwall Council in exercise of its powers under Sections 1, 2, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the **9th** day of **March, 2011** and may be cited as The County of Cornwall (Bodmin) (Fore Street and Honey Street) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2010
2. The County of Cornwall (Bodmin) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

In the First Schedule, No Waiting at Any Time, paragraph 24 (b) relating to Crockwell Street was deleted and substituted with:-

24. Crockwell Street (U6128) (b) west side from its junction with Dennison Road to its junction with Fore Street.

In the First Schedule, No Waiting at Any Time, the following was added:-

In the Twelfth Schedule, Loading Bay At Any Time, paragraph 2 relating to Honey Street is hereby deleted.

In the Thirteenth Schedule, Loading Bay midnight-11am and 1pm-midnight paragraph 1 relating to Fore Street is deleted and substituted with:-

1. Fore Street (B3268) north-east side from a point 3 metres west of its junction with Crockwell Street for a distance of 25 metres in a westerly direction

In the Sixteenth Schedule, Disabled Parking 11am – 1pm paragraph relating to Fore Street is deleted and substituted with:-

1. Fore Street (B3268) north-east side from a point 3 metres west of its junction with Crockwell Street for a distance of 25 metres in a north-westerly direction
