The County of Cornwall (Fowey) (Various Streets) (Loading Bays and Restrictions on Waiting) (Amendment) Order 2010

Cornwall Council in exercise of its powers under Sections 1, 2, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. The Order shall come into force on the **9th** day of **March 2011** and may be cited as The County of Cornwall (Fowey) (Various Streets) (Loading Bays and Restrictions on Waiting) (Amendment) Order 2010.
- 2. The County of Cornwall (Fowey) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:

In the First Schedule, No Waiting at any time, the following was added.

FIRST SCHEDULE No Waiting at Any Time

Lankelly Lane (U6143) south-east side

from its junction with Polvillion Road for a distance of 18

metres in a south-westerly direction.

In the First Schedule, Paragraph 19 - No Waiting at any time relating to Polvillion Road, the following was added:-

Polvillion Road south-east side

from its junction with Lankelly Lane for a distance of 14

Street for a distance of 12 metres in a north-easterly direction

metres in an easterly direction.

In the Fourth Schedule, Loading Bay at any time, paragraphs 1, 2, 3 and 4 relating to Fore Street, Lankelly Lane, Polvillion Road and South Street were deleted and replaced with:-
