

THE COUNTY OF CORNWALL (ST AUSTELL) (VARIOUS STREETS)
(ON-STREET PARKING PLACES AND RESTRICTIONS ON WAITING) (AMENDMENT)
ORDER 2011

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 2, 35 and 35 (and Part IV of Schedule 9) of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:-

1. This Order shall come into force on the 19th day of July 2013 and may be cited as 'The County of Cornwall (St Austell) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2011.
2. The County of Cornwall (Various Streets) (Disabled Persons Street Parking Place) Order 2009 shall have the effect as though:
3. The County of Cornwall (St Austell) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2008 shall have the effect as though:

In Article 2.1.3 after the word "Sixteenth" the following was inserted "and Twentieth".

After Article 3.1.7 the following was inserted:

3.1.8 between 11am and 3pm Monday – Friday (both days inclusive) in the lengths of road specified in the Eighteenth Schedule of this Order.

After Article 3.2.7 the following was inserted:

3.2.8 between the hours of 8am and 6pm, Monday – Saturday (both days inclusive) in the lengths of road specified in the Nineteenth Schedule to this Order-

- i) for a longer period than 20 minutes; or
- ii) if a period of less than 1 hour has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in that length of road.

In Article 5.1 after the word "Sixteenth" the following was inserted "and Twentieth"

 - (iii) From a point 78 metres north-west of its junction with North Street for a distance of 14 metres in a north-westerly direction.
 - (iv) From a point 104 metres north-west of its junction with North Street to its junction with Tremena Gardens.
 - (b) South-west side
From its junction with North Street for a distance of 15 metres in a north-westerly

direction.

In the paragraph relating to Trevarrick Road paragraph (a) was deleted and replaced with the following:

(U6113) From its junction with Truro Road for a distance of 40 metres in a north-westerly direction.

(U6106) (iii) From its junction with Moorland Road for a distance of 15 metres in a south-westerly direction.

(b) South-east side
From a point 6 metres south-west of a point opposite its junction with Tremena Gardens (north-west spur) to its junction with Tremena Road.
- Thornpark Road South-west side
leading to Nos 44-70
(U6107) From a point 5 metres north-west of the south-east corner of its southern parking area for a distance of 9 metres in a north westerly direction.

(U6106) From a point 35 metres south-east of its junction with West Hill to a point 72 metres
