

The County of Cornwall (Threemilestone) (Chyvelah Road and Various Streets) (Restrictions on Waiting) (Amendment) Order 2012

Cornwall Council in exercise of its powers under Sections 1, 2, 32 & 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the 19th day of July 2013 and may be cited as The County of Cornwall (Threemilestone) (Chyvelah Road and Various Streets) (Restrictions on Waiting) (Amendment) Order 2012.

2. The County of Cornwall (Threemilestone) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:

After paragraph 3.1.2 the following was inserted:

3.1.3 - Between 10am and 4pm Monday – Friday (both days inclusive) in the lengths of road specified in the Fifth Schedule to this Order.

Paragraph 3.2.1 (i) was deleted and replaced with the following:
(i) for a longer period than 2 hours; or

After paragraph 2.1.13 the following was inserted:

2.1.14 - "Loading Bay" means any area of highway described in the Sixth Schedule to this Order which is comprised within and indicated by a road marking complying with the Traffic Signs Regulations and General Directions 2002;

In Part 2 Parking Places:

After article 5 the following was inserted:

8. Loading Bays

8.1 The areas of highway specified in the Sixth Schedule to this Order are authorised to be used, subject to the following provisions of this Order, as Loading Bays for the leaving of
(i) such classes of vehicle, in such positions, and for such maximum period, as are specified in Article 6.2 of this Order, and
(ii) on such days and during such hours as specified in the Schedules to this Order.

8.2 No person shall cause or permit a vehicle to wait in a parking place specified in the Schedule :-

8.2.1 unless it is for the time being engaged in the loading or unloading of goods or merchandise;

8.2.2 unless it is wholly within the limits of the parking place and parallel to the side of the road nearest to the vehicle;

8.2.3 for longer than is necessary to enable goods or merchandise to be loaded onto or unloaded from the vehicle

In Part 3 Restrictions on use of Parking Places:

In article 6.1 after the words 'article 5' the words 'and 8' were added.

In article 6.2 after the word 'fourth' the words 'and sixth' were added.
