

**The County of Cornwall (St Ives) (Wheal Ayr Terrace)
(Restrictions on Waiting) (Amendment) Order 2014**

Cornwall Council in exercise of its powers under Sections 1, 2, 32 & 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Order shall come into force on the 2nd day of April 2015 and may be cited as The County of Cornwall (St Ives) (Wheal Ayr Terrace) (Restrictions on Waiting) (Amendment) Order 2014.

2. The County of Cornwall (Various Streets) (Disabled Persons Street Parking Place) Order 2009 shall have effect as though:

In the Schedule the section relating to St Ives was deleted.

3. The County of Cornwall (St Ives) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:

In the First Schedule relating to No waiting at any time:

Paragraphs 4(d)(ii) and (iii) were deleted and replaced with the following:

In the Second Schedule relating to No waiting between 1 March and 31 October:

Paragraph 5 relating to Tregenna Terrace was deleted.

In the Third Schedule relating to No waiting 9am-9pm between 1 March and 31 October:

Paragraphs 1 and 2 were deleted and replaced with the following:

1. Higher Stennack (B3306)
- (a) north-west side
 - from its junction with Carnellis Road to its junction with Park-An-Stamps
 - (b) south-east side
 - (i) from its east junction with the access into Bostennack Place for a distance of 13 metres in a north-easterly direction
 - (ii) from a point 20 metres north-east of its east junction with the access into Bostennack Place to a point 3 metres south-west of the south-west boundary of L'Esperance

- (iii) from its junction with The Burrows to a point 49 metres west of its junction with Penbeagle Lane

In the Fourth Schedule relating to No waiting 9am-6pm between 1 March and 31 October:

Paragraph 1 was deleted and replaced with the following:

- 1. Alexandra Road (U6013)
 - (a) north side
 - (i) from a point 19 metres west of its junction with the unnamed road from Orange Lane to Ventnor Terrace to a point 12 metres east of its junction with Parc Bean Terrace
 - (ii) from a point 9 metres west of its junction with the un-named access road leading to the rear of Parc Bean Terrace to its junction with Access to Rear of Ayr Terrace
 - (iii) from a point 4 metres west of the east boundary of No 1 Alexandra Row to its junction with Burthallan Lane
 - (b) south side
 - from its junction with Access to The Nook to a point 7 metres west of its junction with Alexandra Terrace

In the Eleventh Schedule relating to Disabled Parking Bay at any time:

The paragraph relating to Bostennack Terrace was deleted.

Paragraph 6 was deleted and replaced with the following:

- 6. Higher Stennack (B3306) south-east side
 - from a point 13 metres north-east of its east junction with the access into Bostennack Place for a distance of 7 metres in a north-easterly direction

The following new paragraphs were inserted:

Draycott Terrace (U6016) north side
between points 6 metres and 13 metres west of its gated termination

Penbeagle Crescent (north-east spur) (U6014) north-west side
between points 10 metres and 17 metres north-east of its junction with Penbeagle Crescent (west spur)

Trelawney Avenue
(U6013)

- south side
- (i) between points 83 metres and 90 metres west of its junction with Trerice Road
- (ii) from the east boundary of No 41 for a distance of 7 metres in a westerly direction
