

The County of Cornwall (Liskeard) (Restrictions on Waiting)
(Amendment) Order 2015

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 2, 32 and 35 (and Part IV of Schedule 9) of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act, hereby make the following Order:-

1. This Order shall come into force on the 24th day of December 2015 and may be cited as The County of Cornwall (Liskeard) (Restrictions on Waiting) (Amendment) Order 2015.

2. The County of Cornwall (Liskeard) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:
