# The County of Cornwall (Falmouth) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2021

The Cornwall Council in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

- 1. This Order shall come into force on the 17<sup>th</sup> of October 2022 and may be cited as "The County of Cornwall (Falmouth) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2021".
- 2. The County of Cornwall (Falmouth) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

#### In the Fourth Schedule relating to No waiting at any time:

In paragraph 15 the Road classification number (U6057) was deleted and replaced with the Road number (C0026/U6057). Also, the following was inserted:

15. Boslowick Road (C0026/U6057)

(b) south-east side

(ii) from its junction with Theydon Road for a distance of 9 metres in a south-westerly direction

In the paragraph relating to Empire Way the following was inserted:

Empire Way (U6061)

- (a) north side
- (iii) from a point opposite the western boundary of Unit 4 to a point opposite a point 30 metres north-west of its junction with the access leading to Units 6a-7b
