The County of Cornwall (Falmouth) (St Mary's) (Restrictions on Waiting) (Experimental) Order 2022

Cornwall Council in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 19th day of September 2022 for a period of eighteen months and may be cited as "The County of Cornwall (Falmouth) (St Mary's) (Restrictions on Waiting) (Experimental) Order 2022".

2. In this Order:

- i. any reference to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated or re-enacted by or as having effect by virtue of any subsequent enactment.
- ii. "enactment" means any enactment whether public, general or local and includes any byelaw, rule, regulation, scheme, or other instrument having effect by virtue of an enactment.
- 3. In so far as any provision of this Order conflicts with any provision of any Order previously made or having effect as if it were previously made under the Act of 1984 and which imposes a restriction or prohibition on vehicles or grants an exemption from such restriction or prohibition then that provision of this Order shall prevail.
- 4. Except where provided by Article 3, the prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether made under the Act of 1984 or otherwise.
- 5. The Head of Highways and Infrastructure at Cornwall Council, or a person authorised by him, may modify or suspend the operation of this Order or any provision of it, if it appears to him essential:
 - i. in the interests of the expeditious, convenient and safe movement of traffic;
 - ii. in the interests of providing suitable and adequate on-street parking facilities;or
 - iii. for preserving or improving the amenities of the area through which any road affected by the Order runs.
- 6. The County of Cornwall (Falmouth) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

In the First Schedule relating to No loading at any time:

The following new paragraph was inserted:

Mongleath Road

(C0026)

south side

from the eastern boundary of No 81 for a distance

of 44 metres in an easterly direction

In the Fourth Schedule relating to No waiting at any time:

In paragraph 60 the first sub-paragraph relating to the south side was deleted and replaced with the following:

60. Mongleath Road (C0026)

(a) north side from a point 1 metre east of the western boundary of No 80 to a point 10 metres south of its junction with Queen Anne Gardens

(c) south side
from a point opposite a point 1 metre east of the
western boundary of No 80 to a point 44 metres
east of the eastern boundary of No 81

The following new paragraphs were inserted:

Mongleath Road (spur leading to St Mary's Catholic Primary School) (U6061)

north side

(i) from its junction with Mongleath Road to a point 2 metres east of the eastern boundary of No 72

(ii) from a point 3 metres west of the eastern boundary of No 70 to the northern boundary of No 11 Queen Anne Gardens and including the junction area of the school access

Queen Anne Gardens (U6061)

both sides

from its junction with Mongleath Road for a distance of 10 metres in an easterly direction

In the Twelfth Schedule relating to No waiting Mon-Fri 8am-5pm:

In paragraph 1 relating to Mongleath Road the first sub-paragraph relating to the north side was deleted.
