

**The County of Cornwall (Falmouth) (St Mary's)
(Restrictions on Waiting) Order 2023**

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 14th day of September 2023 and may be cited as "The County of Cornwall (Falmouth) (St Mary's) (Restrictions on Waiting) Order 2023".
2. In this Order:
 - i. any reference to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated or re-enacted by or as having effect by virtue of any subsequent enactment.
 - ii. "enactment" means any enactment whether public, general or local and includes any byelaw, rule, regulation, scheme, or other instrument having effect by virtue of an enactment.
3. The County of Cornwall (Falmouth) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

In the First Schedule relating to No loading at any time:

The following new paragraph was inserted:

Mongleath Road (C0026)	south side from the eastern boundary of No 81 for a distance of 44 metres in an easterly direction

In the Fourth Schedule relating to No waiting at any time:

Queen Anne Gardens (U6061)		both sides from its junction with Mongleath Road for a distance of 10 metres in an easterly direction
