## The County of Cornwall (Fowey) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2019

THE CORNWALL COUNCIL in exercise of their powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9) to the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

- 1. The Order shall come into force on the 19th day of October 2020 and may be cited as "The County of Cornwall (Fowey) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2019".
- 2. The County of Cornwall (Fowey) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:

In the opening paragraph of Article 3 the words 'parking places' were deleted and replaced with the words 'the parking places specified in Part II – Parking Places'.

Article 7 relating to Street Parking Place was deleted.

Article 8 relating to Solo Motorcycle Parking Place was deleted.

In Article 9.1 the words '5, 6, 7 and 8' were deleted and replaced with the words '5 and 6'.

Article 9.2 relating to the position of a vehicle within a parking place was deleted.

In Articles 9.9 and 9.10 the words 'traffic warden' were deleted and replaced with the words 'Civil Enforcement Officer'.

## In the First Schedule relating to No waiting at any time:

Paragraph 23 was deleted and replaced with the following:

- 23. South Street (C0772)
- (a) east side for its entire length
- (b) west side
- (i) from its junction with Lostwithiel Street to a point 1 metre south of the north side of its junction with Church Avenue
- (ii) from a point 6 metres north of its junction with Church Avenue to its junction with Fore Street

Paragraph 27 relating to Unclassified Road Leading To The Town Hall was deleted and replaced with the following:

27. Trafalgar Square (U6143)

(a) north side

(i) from its junction with South Street for a distance of 4 metres in an easterly direction

(ii) from a point 15 metres east of its junction with South Street to its termination at Town Quay

(b) south side from its junction with Lostwithiel Street to its termination at Town Quay

## In the Fourth Schedule relating to Loading bay at any time:

Paragraph 2 relating to South Street was deleted and replaced with the following:

2. South Street (C0772)

west side between points 1 metre south and 6 metres north of the north side of its junction with Church Avenue

In the Sixth Schedule relating to Disabled parking bay 3 hours no return within 3 hours:

Paragraph 1 relating to Unclassified Road Leading To The Town Hall was deleted and replaced with the following:

Trafalgar Square (U6143)

north side between points 4 metres and 15 metres east of its junction with South Street

The Ninth Schedule relating to Street Parking Place 30 minutes no return within 1 hour daily was deleted.

The Tenth Schedule relating to Motorcycle Parking Place 30 minutes no return within 1 hour was deleted.
