The County of Cornwall (Fowey) (Various Streets) (Restrictions of Waiting) (Amendment) Order 2022

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. This Order shall come into force on the 15th day of December 2023 and may be cited as "The County of Cornwall (Fowey) (Various Streets) (Restrictions of Waiting) (Amendment) Order 2022".
- 2. The provisions of "The County of Cornwall (Fowey) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009" shall have the effect as though:

In the First Schedule relating to No waiting at any time:

Paragraph 8 was deleted and replaced with the following:

- 8. Langurtho Road (U6143)
- (a) both sides from its junction with Park Road/Polvillion Road (spur leading to Park Road) for a distance of 16 metres in a northerly direction
- (b) east side from its western junction with Polvillion Road for a distance of 15 metres in a northerly direction
- (c) west side from its western junction with Polvillion Road for a distance of 13 metres in a northerly direction

Paragraphs 13(a) and (c) were deleted and replaced with the following:

13. Park Road (U6143)

- (a) north side from its junction with Langurtho Road for a distance of 146 metres in an easterly direction
- (c) south side from its junction with Polvillion Road (spur leading to Park Road) to the western boundary of No 2

Paragraph 18 relating to Polvillion was deleted and replaced with the following:

18. Polvillion Road (spur leading to Park Road) (U6143)

(a) north sidefrom a point 5 metres east of its junction withPolvillion Road to its junction with Langurtho Road

(b) south side for its entire length

Paragraph 19 was deleted and replaced with the following:

19. Polvillion Road (B3415)

(a) both sides from its junction with Polvillion Road (spur leading to Park Road) to its junction with New Road Hill

(b) north sidefrom a point 16 metres west of its junction withLangurtho Road to the eastern boundary of No 17

(c) south side from its junction with Lankelly Lane for a distance of 14 metres in an easterly direction

The following new paragraph was inserted:

Readymoney Road (U6143)

both sides for its entire length

In the Second Schedule relating to No waiting between 01 May and 30 Sep:

Paragraph 3 relating to Readymoney Road was deleted.
