

**The County of Cornwall (Carrick) (Goonhavern and St Newlyn East)
(Restrictions on Waiting) (Amendment) Order 2020**

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32 and 35 (and Part IV of Schedule 9) to the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the *1st* day of *April* 2021 and may be cited as "The County of Cornwall (Carrick) (Goonhavern and St Newlyn East) (Restrictions on Waiting) (Amendment) Order 2020".
2. The County of Cornwall (Carrick) (Rural Settlements) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

GOONHAVERN

The following new Schedules were inserted:

- (ii) from a point 2 metre west of the eastern boundary of No 25 to a point 4 metres south of the northern boundary of No 24
