# The County of Cornwall (Gulval & Ludgvan) (Various Roads) (Restrictions on Waiting) (Amendment) Order 2024

THE CORNWALL COUNCIL in exercise of its powers under Section 1, 32 and 35 (and Section IV of Schedule 9) of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 12th day of February 2024 and may be cited as "The County of Cornwall (Gulval & Ludgvan) (Various Roads) (Restrictions on Waiting) (Amendment) Order 2024".

### 2. In this Order:

- i. "enactment" means any enactment whether public, general or local and includes any byelaw, rule, regulation, scheme, or other instrument having effect by virtue of an enactment; and
- ii. any reference to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated or re-enacted by or as having effect by virtue of any subsequent enactment.
- 3. The County of Cornwall (Penwith) (Rural Settlements) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:
