

**The County of Cornwall (Hayle) (Various Streets)  
(On-Street Parking Places and Restrictions on Waiting)  
(Amendment) Order 2016**

Cornwall Council in exercise of its powers under Sections 1, 2, 32 and 35 (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the 12<sup>th</sup> day of February 2018 and may be cited as "The County of Cornwall (Hayle) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2016".

2. The County of Cornwall (Various Streets) (Disabled Persons Street Parking Place) Order 2009 shall have effect as though:

**The section relating to Hayle was deleted.**

3. The County of Cornwall (Hayle) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2008 shall have effect as though:

After Article 3.1.8 the following was inserted:

in the lengths of road specified in the Fourteenth Schedule to  
this Order.

After Article 3.2.3 the following was inserted:

(both days inclusive) in the length of road specified in the  
Thirteenth Schedule to this Order -
- (i) for a longer period than 30 minutes; or  
(ii) if a period of less than 1 hour has elapsed since the  
termination during the said hours of the last period of waiting  
(if any) of the vehicle in that length of road.
