

**The County of Cornwall (Hayle) (Various Streets)  
(Restrictions on Waiting) (Amendment) Order 2022**

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the *12<sup>th</sup>* day of *July* 2023 and may be cited as 'The County of Cornwall (Hayle) (Various Streets) (Restrictions on Waiting) (Amendment) Order 2022'.
2. The County of Cornwall (Hayle) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2008 shall have effect as though:

Paragraphs 39(b) and (c) were deleted and replaced with the following:

between points 32 metres and 75 metres south of its junction with Godrevy Towans

1. Church Road

- (a) both sides
  - (i) from its junction with Tyringham Road/Station Hill to a point 5 metres south-west of the north-eastern boundary of Tregarthen
  - (ii) from the north-eastern building boundary of The Ship House to the south-western boundary of Chywyn
  - (iii) between points 11 metres south-west and 15 metres north-east of its junction with The Saltings
- (b) north-west side  
from a point 5 metres south-west of the north-eastern boundary of Tremar to a point 19 metres north-east of its junction with Church Close


