## The County of Cornwall (Helston) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Part 2) (Amendment) Order 2012

Cornwall Council in exercise of its powers under Sections 1, 2, 32 and 35 (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. The Order shall come into force on the 19th day of Juy 2013 and may be cited as "The County of Cornwall (Helston) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Part 2) (Amendment) Order 2012"
- 2. The County of Cornwall (Helston) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

## In the Second Schedule relating to No Waiting at Any Time:

Paragraphs 37(a) relating to Wendron Street was deleted in its entirety and replaced with the following:

37. Wendron Street (A0394)

(a) north-west side

(i) from its junction with Market Place for a distance of 54 metres in a north-easterly direction

(ii) from a point 85 metres south-west of its junction with Penrose Road for a distance of 39 metres in a south-westerly direction

(iii) from a point 32 metres south-west of its junction with Penrose Road for a distance of 10 metres in a south-westerly direction

## In the Fourth Schedule relating to Limited Waiting Mon-Sat 9am-6pm 30 minutes no return within 1 hour:

Paragraph 5 was deleted in its entirety and replaced with the following:

5. Wendron Street (A0394)

north-west side

(i) from a point 42 metres south-west of its junction with Penrose Road for a distance of 42 metres in a south-westerly direction

(ii) from a point 124 metres south-west of its junction with Penrose Road to a point 54 metres north-east of its junction with Market Place
