THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

In the section relating to Praze-an-Beeble:

In the Seventeenth Schedule relating to Disabled parking bay at any time:

In the paragraph relating to Fore Street paragraph a(i) was deleted.

3. The County of Cornwall (Illogan Highway & Pool) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

In the First Schedule relating to No waiting at any time:

Paragraph 10 was deleted and replaced with the following:

10. Crembling Well (U6046)

both sides

from its junction with Barncoose Terrace to a point 2 metres south-west of the north-eastern boundary of No 18

Paragraph 11 was deleted and replaced with the following:

- 11. Druid's Road (U6044)
- (a) east side
- (i) from its junction with Agar Road to a point 1 metre south of the northern boundary of No 3
- (ii) between points 1 metre north and 7 metres south of the northern boundary of No 5

- (iii) from a point 7 metres north of the northern boundary of No 11 to a point 1 metre south of the northern boundary of No 15
- (iv) from a point 1 metre south of the northern boundary of No 19 to a point 1 metre south of the northern boundary of No 21
- (v) from a point 1 metre north of the northern boundary of No 23 to a point 8 metres south of its junction with Druid's Lodge
- (b) west side
- (i) from its junction with Agar Road to a point 1 metre south of the southern boundary of No 8
- (ii) from a point 14 meters south-east of the southern boundary of No 8 to a point opposite a point 8 metres south of its junction with Druid's Lodge

Paragraph 12(b) was deleted and replaced with the following:

- 12. Dudnance Lane (A3047)
- (b) south-west side from its junction with East Hill to a point 9 metres south-east of its junction with Pool Business Park
- (c) both sides
 between points 10 metres north-east and 13
 metres south-west of its junction with Station Road

Paragraph 18(b)(ii) was deleted and replaced with the following:

- 18. Station Road (C0103)
- (a) east side
- (ii) from its junction with Dudnance Lane for a distance of 27 metres in a northerly direction
- (b) west side
- (ii) from a point 117 metres north of the centre of its junction with Carn Brea Avenue to its junction with Dudnance Lane

Paragraph 28(c) was deleted and replaced with the following:

Wilson Way (C3047)

- (i) from its junction with Barncoose Roundabout to a point 17 metres west of its junction with Druid's Road (north)

- (iii) between points 18 metres and 39 metres west of a point opposite the western boundary of Denwood

both sides from its junction with Wilson Way for a distance of

17 metres in a south-easterly direction

Pool Business Park (Unadopted)

both sides

from its junction with Dudnance Lane for a distance of 11 metres in a south-westerly direction

Pool Industrial Estate (U6044)

- (a) north side
- (i) from its junction with Druid's Road to a point 6 metres west of the access to Units 6A-7E
- (ii) between points 11 metres east and 14 metres west of its junction with Pool Industrial Estate (north spur)
- (b) south side from its junction with Druid's Road to the eastern access to Unit 11

Pool Industrial Estate (north spur) (U6044)

- (a) east side from its junction with Pool Industrial Estate for a distance of 26 metres in a northerly direction
- (b) west side from its junction with Pool Industrial Estate for a distance of 17 metres in a northerly direction
