The County of Cornwall (Illogan Highway) (Barncoose) (Restrictions on Waiting) (Amendment) Order 2017

Cornwall Council in exercise of its powers under Sections 1 and 2 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. The Order shall come into force on the Hay and May 2018 and may be cited as "The County of Cornwall (Illogan Highway) (Barncoose) (Restrictions on Waiting) (Amendment) Order 2017".
- 2. The County of Cornwall (Illogan Highway and Pool) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

In the opening paragraph of Article 3 the words 'parking places' were deleted and replaced with the words 'the parking places specified in Part II – Parking Places'.

In Part III RESTRICTIONS ON USE OF PARKING PLACES

Article 7.2 relating to the position of a vehicle within a parking place was deleted.

In Articles 7.9 and 7.11 the words 'traffic warden' were deleted and replaced with the words 'Civil Enforcement Officer'.

In the First Schedule relating to No waiting at any time:

In paragraph 2 relating to Agar Road the road number (A3047) was deleted and replaced with (C0776).

All 3 paragraphs relating to Barncoose Mini Roundabout along with its northern and southern spurs were deleted.

In the paragraph relating to Barncoose Roundabout the reference to an unknown road number was deleted and replaced with (A3047).

The paragraphs relating to Barncoose Roundabout north-western and south-eastern spurs were deleted.

In paragraph 12 relating to Dudnance Lane the road number (C0710) was deleted and replaced with (A3047).

In the paragraph relating to Fordh An Bal the road number (Unadopted) was deleted and replaced with (U6044).

In paragraph 14 relating to Fore Street the road number (A3047) was deleted and replaced with (C0776).

The paragraph relating to Road between Barncoose Roundabout and Barncoose Mini Roundabout was deleted

The paragraph relating to Road between Barncoose Terrace and Barncoose Roundabout including eastern and northern access roads was deleted.

In the paragraph relating to Robinsons Avenue the road number (Unadopted) was deleted and replaced with (Unclassified).

Paragraph 19 was deleted and replaced with the following:

19. Tolvaddon Road (A3074)

both sides from its junction with Trevenson Road/East Hill for a distance of 70 metres in a north-westerly direction

In paragraph 21 the road number (A3047) was deleted and replaced with (C0776). Also, paragraph 21(a) was deleted and replaced with the following:

21. Trevenson Road (C0776)

(a) north-west side from its junction with Tolvaddon Road to a point 3 metres north-east of the north-eastern boundary of No 128

The paragraph relating to Unnamed access road leading to Heartlands car park was deleted.

In paragraph 28 relating to Wilson Way the road number (U6044) was deleted and replaced with (A3047/U6044).
