
The County of Cornwall (Kerrier) (Illogan & Troon) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2022

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32, 35, 45, 46 and 49 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. This Order shall come into force on the $2^{\circ \circ}$ day of \circ 2024 and may be cited as "The County of Cornwall (Kerrier) (Illogan & Troon) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2022".
- 2. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:
- "enactment" means any enactment whether public, general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment;
- "Map Schedules" means the plans, including their keys, annexed to The County of Cornwall (West Central Cornwall) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2024; and
- "Map Tiles" means the plans, including their keys, contained in the Schedule to this Order.
- 3. Unless expressly stated to the contrary, any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated or reenacted by, or as having effect by virtue of, any subsequent enactment.
- 4. Save as provided in Article 5, the Map Schedules are hereby varied by the extents shown on the Map Tiles.
- 5. Any existing prohibitions, restrictions or designations applying to any lengths of road or sides of any lengths of road prior to this Order coming into force, which are not referenced on the Map Tiles, shall be deemed to be excluded from the aforementioned variation.

Coloured spots


Restrictions with different attributes are marked with a lettered spot


