

**The County of Cornwall (Kerrier) (Rural Settlements)  
(On-Street Parking Places and Restrictions on Waiting) (Amendment) (Part 1) Order 2021**

Cornwall Council in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. This Order shall come into force on the <sup>25<sup>th</sup></sup> day of *August* 2022 and may be cited as "The County of Cornwall (Kerrier) (Rural Settlements) (On-Street Parking Places and Restrictions on Waiting) (Amendment) (Part 1) Order 2021".
2. The County of Cornwall (Kerrier) (Rural Settlements) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though: After Article 3.2.5 the following new Article was inserted:

3.2.6                      at any time in the length of road specified in the Twentieth Schedule to this Order -

- (i) for a longer period than 30 minutes; or
- (ii) if a period of less than 2 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in that length of road.
