

The County of Cornwall (Kerrier) (South Kerrier) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2023

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the *26th* day of *February* 2024 and may be cited as "The County of Cornwall (Kerrier) (South Kerrier) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2023".
2. The County of Cornwall (Kerrier) (Rural Settlements) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

After Article 3.2.6 the following new Article was inserted:

- 3.2.7 between the hours of 7.30am and 6pm, Monday to Saturday (both days inclusive) in the length of road specified in the Twenty-Second Schedule to this Order -
- (i) for a longer period than 30 minutes; or
(ii) if a period of less than 2 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in that length of road.

from a point 5 metres west of the eastern boundary of Sunny Bank for a distance of 53 metres in a westerly direction
