The County of Cornwall (Launceston) (Various Streets) (Restrictions on Waiting) (Amendment) Order 2020

Cornwall Council in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

In the Second Schedule relating to No waiting at any time:

Paragraph 9 was deleted and replaced with the following:

In paragraph 20 the following was inserted:
