The County of Cornwall (Lostwithiel) (Various Streets) (Restrictions on Waiting) (Amendment) Order 2021

Cornwall Council in exercise of its powers under Section 1 of (and Part IV of Schedule 9 to) the Road Traffic Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

- 1. This Order shall come into force on the 11th day of May 2022 and may be cited as "The County of Cornwall (Lostwithiel) (Various Streets) (Restrictions on Waiting) (Amendment) Order 2021".
- 2. The County of Cornwall (Lostwithiel) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

In the Second Schedule relating to No waiting at any time:

In Paragraph 1 the following was inserted:

1. Bodmin Hill (U6141)

- (a) north-east side
- (ii) between points 6 metres north-west and 5 metres south-east of its junction with Duke Street
- (iii) from a point 6 metres south-east of its junction with Trewince Lane for a distance of 20 metres in a north-westerly direction
- (b) south-west side
- (ii) from a point opposite a point 6 metres south-east of its junction with Trewince Lane to a point 3 metres south-east of its junction with The Brambles

In Paragraph 3 the following was inserted:

3. Castle Hill (C0352)

- (a) both sides
- (ii) from its junction with Edgcumbe Road to a point 10 metres north-east of the north-eastern boundary of No 2
- (b) north-west side between points 7 metres and 30 metres south-west of the south-western boundary of No 2

In paragraph 4 the following was inserted:

4. Church Lane (U6144)

(c) both sides from its junction with North Street for a distance of 8 metres in a southerly direction Paragraph 6(a) was deleted and replaced with the following:

6. Duke Street (U6141)

- (a) north-east side
 from its junction with Liddicoat Road to the north-western boundary of Royal Talbot
- (b) south-west side
- (iii) from the north-western boundary of No 18 Bodmin Road to its junction with Bodmin Hill

Paragraph 12 relating to Mill Gardens was deleted.

In paragraph 15 the following was inserted:

15. North Street (B3268)

- (d) south-west side
- (ii) from its junction with Church Lane for a distance of 4 metres in a south-easterly direction

In Paragraph 17 the following was inserted:

17. Quay Street (U6144)

- (a) east side
- (ii) between the northern and southern building boundaries of No 4
- (b) west side
- (ii) from the southern building boundary of No 7 for a distance of 17 metres in a northerly direction

In Paragraph 21 the following was inserted:

21. Summers Street (U6144)

- (b) west side
- (iii) between points 1 metre and 39 metres north-east of a point opposite the south-western boundary of No 4

Paragraph 22 was deleted and replaced with the following:

22. Tanhouse Road (B3268)

- (a) north-east side from a its junction with Queen Street to a point 11 metres north-west of the north-western boundary of Chy-an-Rudhak
- (b) south-west side from its junction with Edgcumbe Road to a point 11 metres south-east of the north-western boundary of No 4 Mill Gardens

The following new paragraphs were inserted:

Albert Terrace (U6141)

- (a) north-west side between points 1 metre and 11 metres south-west of the north-eastern boundary of No 1
- (b) south-east side
- (i) between points 2 metres and 11 metres south-west of a point opposite the north-eastern boundary of No 1
- (ii) between points 4 metres and 9 metres south-west of a point opposite the south-western boundary of No 2

Uzella Park (U6141)

north-east side between points 27 metres and 42 metres northwest of the north-western boundary of No 45

In the Fourth Schedule relating to No waiting 9am - 6pm

Paragraph 1 was deleted and replaced with the following:

1. Albert Terrace (U6141)

- (a) north-west side from a point 11 metres south-west of the northeastern boundary of No 1 to a point 23 metres north-east of south-western boundary of No 2
- (b) south-east side
 from a point 11 metres south-west of a point
 opposite the north-eastern boundary of No 1 to a
 point 4 metres south-west of a point opposite the
 south-western boundary of No 2

Paragraph 3 relating to Tanhouse Road was deleted.
