

The County of Cornwall (Marazion) (Restrictions on Waiting) (Amendment) Order 2021

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Order shall come into force on the 17th day of August 2023 and may be cited as "The County of Cornwall (Marazion) (Restrictions on Waiting) (Amendment) Order 2021".
2. The County of Cornwall (Penwith) (Rural Settlements) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:

After Article 3.2.6 the following new Articles were inserted:

- 3.2.7 on any day in the lengths of road specified in the Seventeenth Schedule to this Order -
- (i) for a longer period than 2 hours; or
 - (ii) if a period of less than 2 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in that length of road.
- 3.2.8 between the hours of 9am and 6pm in the lengths of road specified in the Eighteenth Schedule to this Order -
- (i) for a longer period than 2 hours; or
 - (ii) if a period of less than 2 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in that length of road.
