

## **The County of Cornwall (Newquay) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) (Part 2) Order 2019**

Cornwall Council in exercise of its powers under Section 1 of (and part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 7<sup>th</sup> day of *December* 2020 and may be cited as "The County of Cornwall (Newquay) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) (Part 2) Order 2019".
2. The County of Cornwall (Newquay) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2012 shall have effect as though:

### **In the Second Schedule relating to No waiting at any time:**

In paragraph 10 the following was inserted:

from a point 1 metre west of the eastern boundary of No 13 to a point 6 metres west of the eastern boundary of No 11

The paragraph relating to Pydar Close (north spur) was deleted and replaced with the following:

- (a) south side
  - (i) from the north-western boundary of No 56 for a distance of 24 metres in an easterly direction including the turning area
  - (ii) from a point 1 metre east of the north-western boundary of No 49 to a point 8 metres east of its junction with Pydar Close (link road)

In paragraph 128 the following was inserted:

128. Trevenson Road  
(C0181)

- (b) west side
- (iv) between points 9 metres south and 10 metres north of its junction with Pydar Close

The following new paragraph was inserted:



  - (ii) from its junction with Pydar Close (north spur) for a distance of 10 metres in a southerly direction

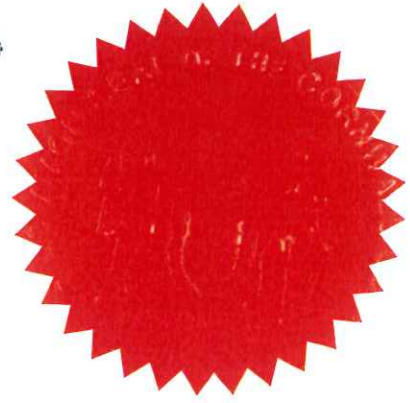
