The County of Cornwall (Newquay) (Tregunnel Hill) (Restrictions on Waiting) (Amendment) Order 2020

Cornwall Council in exercise of its powers under Sections 1 (and Part IV of Schedule 9) of the Road Traffic Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. This Order shall come into force on the 24th of August 2020 and may be cited as "The County of Cornwall (Newquay) (Tregunnel Hill) (Restrictions on Waiting) (Amendment) Order 2020".
- 2. The County of Cornwall (Newquay) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2012 shall have effect as though:

In the Second Schedule relating to No waiting at any time:

Paragraph 113(b) was deleted and replaced with the following:

113. Tregunnel Hill (U6089)

(b) north-west side from its junction with Gannel Road to a point 12 metres north of its junction with Stret Caradoc

The following new paragraphs were inserted:

Access road to Tregunnel (a) Hill Car Park

(a) east side

from its junction with Stret Caradoc for a distance of 12 metres in a southerly direction

(Unclassified)

(b) west side

from its junction with Stret Caradoc for a distance of 13 metres in a southerly direction

Stret Caradoc (Unclassified)

both sides

from its junction with Tregunnel Hill to a point 1 metre north-west of the south-eastern boundary of No 27

Stret Constantine (Unclassified)

(a) east side

from its eastern junction with Stret Caradoc for a distance of 17 metres in a southerly direction

(b) west side from its eastern junction with Stret Caradoc for a distance of 18 metres in a southerly direction In the Fifth Schedule relating to No waiting 9am to 9pm between 01 May and 30 Sep:

Paragraph 42(b) was deleted and replaced with the following:

- 42. Tregunnel Hill (U6089)
- (b) west side from a point 12 metres south of its junction with Mount Wise to a point 12 metres north of its junction with Stret Caradoc
